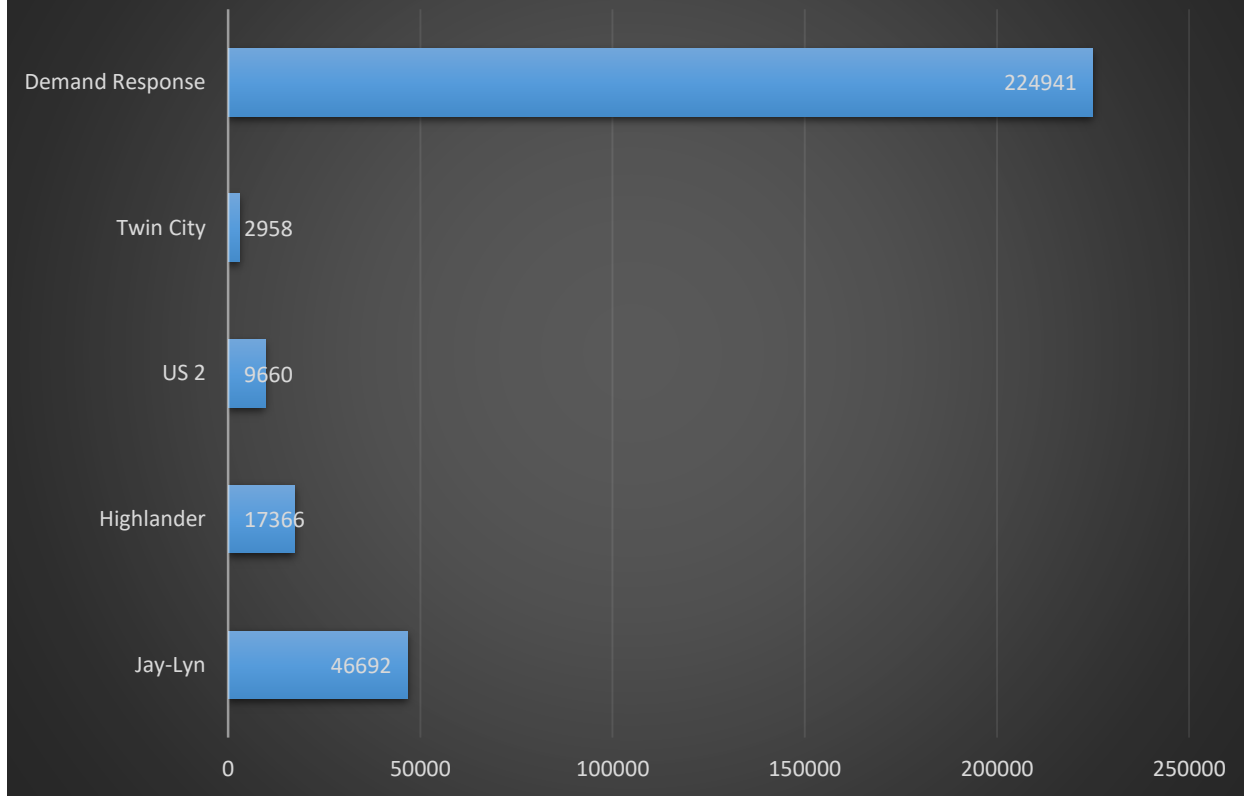

Our **Mission** is to provide public transportation services for everyone that are safe, reliable, accessible and affordable to enhance the economic, social and environmental health of the communities we serve.

Rural Community Transportation, Inc. (RCT), is a private non-profit 501(c)(3) corporation which provides public transportation services throughout Caledonia, Orleans, Essex and Lamoille Counties. RCT operates fare-free shuttle and commuter bus routes which allow connections between towns in our region as well as the ability to travel throughout Vermont and beyond. In addition, RCT provides demand response transportation services under several programs, such as Medicaid, the Elderly & Disabled program and Rides 2 Wellness. Using our network of dedicated volunteer and staff drivers, RCT provided over 300,000 rides in fiscal year 2019.
